## A BILL

To reauthorize the North Korean Human Rights Act of 2004, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "North Korean Human
- 5 Rights Reauthorization Act of 2022".
- 6 SEC. 2. FINDINGS.
- 7 Congress finds the following:
- 8 (1) The North Korean Human Rights Act of
- 9 2004 (Public Law 108–333; 22 U.S.C. 7801 et seq.)

1	and subsequent reauthorizations were the product of
2	broad, bipartisan consensus regarding the promotion
3	of human rights, documentation of human rights
4	violations, transparency in the delivery of humani-
5	tarian assistance, and the importance of refugee pro-
6	tection.
7	(2) The human rights and humanitarian condi-
8	tions within the Democratic People's Republic of
9	North Korea (DPRK) remain deplorable and have
10	been intentionally perpetuated against the people of
11	North Korea through policies endorsed and imple-
12	mented by Kim Jong-Un and the Korean Workers'
13	Party.
14	(3) According to a 2014 report released by the
15	United Nations Commission of Inquiry, between
16	80,000 and 120,000 children, women, and men are
17	currently being held in political prison camps in
18	North Korea and are subjected to deliberate starva-
19	tion, forced labor, executions, torture, rape, forced
20	abortion, and infanticide.
21	(4) North Korea continues to hold a number of
22	South Koreans abducted after the signing of the
23	1953 armistice agreement and refuses to acknowl-
24	edge the abduction of over 100,000 South Koreans

1	during the Korean war in violation of the Geneva
2	Convention.
3	(5) Human rights violations in North Korea,
4	which include forced starvation, sexual violence
5	against women and children, restrictions on freedom
6	of movement, arbitrary detention, torture, execu-
7	tions, and enforced disappearances, amount to
8	crimes against humanity according to the United
9	Nations Commission of Inquiry (COI) on Human
10	Rights in the DPRK.
11	(6) The effects of the COVID-19 pandemic and
12	the DPRK's strict lockdown of its borders and
13	crackdowns on informal market activities and small
14	entrepreneurship have drastically increased food in-
15	security for its people and given rise to famine con-
16	ditions in parts of the country.
17	(7) The DPRK's COVID-19 border lockdown
18	measures also include shoot-to-kill orders that has
19	resulted in the killing of North Koreans attempting
20	to cross the border and at least one South Korean
21	citizen in September 2020.
22	(8) The Government of the People's Republic of
23	China (PRC) is aiding and abetting in crimes
24	against humanity by forcibly repatriating North Ko-
25	rean refugees to the DPRK. Upon repatriation,

1	North Koreans are sent to prison camps, harshly in-
2	terrogated, tortured, or executed. The Government
3	of the People's Republic of China's forcible repatri-
4	ation of North Korean refugees violates its non-
5	refoulement obligations, under the United Nations
6	Convention Relating to the Status of Refugees, done
7	at Geneva July 28, 1951 (as made applicable by the
8	Protocol Relating to the Status of Refugees, done at
9	New York January 31, 1967 (19 UST 6223)).
10	(9) The DPRK continues to bar freedom of re-
11	ligion and persecute religious minorities, especially
12	Christians. Eyewitnesses reported that Christians in
13	North Korea have been tortured, forcibly detained,
14	and even executed for possessing a Bible or pro-
15	fessing Christianity.
16	(10) Broadcasting operations into the DPRK
17	serve as a critical source of outside news and infor-
18	mation for the North Korean people and provides a
19	valuable service for countering propaganda and false
20	narratives.
21	(11) The position of Special Envoy on North
22	Korean Human Rights Issues has been vacant since
23	January 2017, although the President is required to
24	appoint a Senate-confirmed Special Envoy to fill this
25	position in accordance with section 107 of the North

1	Korean Human Rights Act of 2004 (22 U.S.C.
2	7817).
3	SEC. 3. SENSE OF CONGRESS.
4	It is the sense of Congress that—
5	(1) promoting information access in North
6	Korea continues to be a successful method of coun-
7	tering DPRK propaganda and the United States
8	Government should continue to support nongovern-
9	mental radio broadcasting to North Korea and pro-
10	mote other emerging methods in this space;
11	(2) because refugees among North Koreans
12	fleeing into China face severe punishments upon
13	their forcible return, the United States should urge
14	the Government of the People's Republic of China
15	to—
16	(A) immediately halt its forcible repatri-
17	ation of North Koreans who would face perse-
18	cution or torture upon return;
19	(B) allow the United Nations High Com-
20	missioner for Refugees (UNHCR) unimpeded
21	access to North Koreans inside China to deter-
22	mine whether they are refugees and whether
23	they require assistance;
24	(C) fulfill its obligations under the 1951
25	United Nations Convention Relating to the Sta-

1	tus of Refugees, the 1984 Convention against
2	Torture and Other Cruel, Inhuman or Degrad-
3	ing Treatment or Punishment, the 1967 Pro-
4	tocol Relating to the Status of Refugees, and
5	the Agreement on the Upgrading of the
6	UNHCR Mission in the People's Republic of
7	China to UNHCR Branch Office in the Peo-
8	ple's Republic of China (signed December 1,
9	1995);
10	(D) address the concerns of the United
11	Nations Committee against Torture by incor-
12	porating into domestic legislation the principle
13	of non-refoulement; and
14	(E) recognize the legal status of North Ko-
15	rean women who marry or have children with
16	Chinese citizens, and ensure that all such moth-
17	ers and children are granted resident status
18	and access to education and other public serv-
19	ices in accordance with Chinese law and con-
20	sistent with international standards;
21	(3) the United States Government should con-
22	tinue to promote the effective and transparent deliv-
23	ery and distribution of any humanitarian aid pro-
24	vided in North Korea to ensure it reaches its in-
25	tended recipients to the point of consumption or uti-

1	lization by cooperating closely with the Government
2	of the Republic of Korea and international and non-
3	governmental organizations;
4	(4) the United States currently blocks United
5	States passports from being used to travel to North
6	Korea without a special validation from the Depart-
7	ment of State, and the Department of State should
8	continue to take steps to increase public awareness
9	about the risks and dangers of travel by United
10	States citizens to North Korea;
11	(5) the United Nations has a significant role to
12	play in promoting and improving human rights in
13	North Korea and should press for access for the
14	Special Rapporteur on the situation of human rights
15	in North Korea, as well as for the United Nations
16	High Commissioner for Human Rights;
17	(6) the Special Envoy for North Korean
18	Human Rights Issues should be appointed without
19	delay to properly promote and coordinate North Ko-
20	rean human rights and humanitarian issues and to
21	participate in policy planning and implementation
22	with respect to refugee issues;
23	(7) the United States should urge North Korea
24	to repeal the Reactionary Thought and Culture De-
25	nunciation Law and other draconian laws, regula-

1	tions, and decrees as their implementation mani-
2	festly violates the rights to freedom of opinion and
3	expression and freedom of thought, conscience, and
4	religion;
5	(8) the United States should urge North Korea
6	to ensure that any restrictions on addressing the
7	COVID-19 pandemic are necessary, proportionate
8	nondiscriminatory, time-bound, and transparent, and
9	allow international staff to operate inside the DPRK
10	to provide international assistance based on inde-
11	pendent needs assessments;
12	(9) the United States should continue to seek
13	cooperation from all foreign governments to allow
14	the UNHCR access to process North Korean refu-
15	gees overseas for resettlement; and
16	(10) the Secretary of State, through diplomacy
17	by senior officials, including United States ambas-
18	sadors to Asia-Pacific countries, and in close co-
19	operation with South Korea, should make every ef-
20	fort to promote the protection of North Korean refu-
21	gees, escapees, and defectors.
22	SEC. 4. ACTIONS TO PROMOTE FREEDOM OF INFORMA
23	TION.

1	SEC. 7. REPORT BY UNITED STATES AGENCY FOR GLOBAL
2	MEDIA.
3	Not later than 120 days after the date of the enact-
4	ment of this Act, the Chief Executive Officer of the United
5	States Agency for Global Media shall submit to the Com-
6	mittee on Foreign Affairs of the House of Representatives
7	and the Committee on Foreign Relations of the Senate
8	a report that—
9	(1) describes the status of current United
10	States broadcasting to North Korea and the extent
11	to which the Agency has achieved the goal of 12-
12	hour-per-day broadcasting to North Korea, in ac-
13	cordance with section 103(a) of the North Korean
14	Human Rights Act of 2004 (22 U.S.C. 7813(a));
15	and
16	(2) includes a strategy to overcome obstacles to
17	such broadcasting, including through unrestricted,
18	unmonitored, and inexpensive electronic means.
19	SEC. 8. SENSE OF CONGRESS REGARDING KOREAN-AMER-
20	ICAN DIVIDED FAMILIES.
21	It is the sense of Congress that—
22	(1) the United States and North Korea should
23	begin the process of reuniting Korean-American di-
24	vided family members with their immediate relatives
25	through ways such as—

1	(A) identifying divided families in the
2	United States and North Korea who are willing
3	and able to participate in a pilot program for
4	family reunions;
5	(B) finding matches for members of such
6	families through organizations such as the Red
7	Cross; and
8	(C) working with the Government of South
9	Korea to include American citizens in inter-Ko-
10	rean video reunions;
11	(2) the institution of family is inalienable and
12	the restoration of contact between divided families
13	whether physically, literarily, or virtually is an ur-
14	gent need; and
15	(3) the United States and North Korea should
16	pursue reunions as a humanitarian priority of imme-
17	diate concern.
