1 Be it enacted by the Senate and House of Representa-

5	(a) Certification by the Foreign Claims Set-
6	TLEMENT COMMISSION.—The Foreign Claims Settlement
7	Commission shall—
8	(1) not later than 30 days after the date of the

10	ister a notice of a process for filing claims on behalf

10	with subsection (c).
11	(c) Compensation.—
12	(1) In general.—Upon a certification by the
13	Foreign Claims Settlement Commission under sub-
14	section (a)(3) of the claim of a compensable living
15	victim of Libyan State-sponsored terrorism, the
16	claimant (or, in the case of a deceased claimant, the
17	personal representative of the claimant's estate)
18	shall be entitled to an award in an amount equal
19	to—
20	(A) \$42,066,338, divided by
21	(B) the total number of claims certified
22	under subsection $(a)(3)$ .
23	(2) Representative.—If a putative claimant
24	that otherwise qualifies for compensation under this
